- 1. The Stallion Fee stated above includes a non-refundable booking fee which shall be payable upon execution of this contract. THE BALANCE OF THE STUD FEE SHALL BE PAID IN FULL BEFORE OR ON THE DAY OF THE FIRST SEMEN SHIPMENT.
- 2. The breeding season will begin Monday, 2/3/2025 and continue through Monday, 6/30/2025. Collection days will be Monday, Wednesday and Friday ONLY. IT WILL BE THE MARE OWNER AND HIS/HER VETERINARIAN'S RESPONSIBILITY TO CONFIRM OUR BREEDING/SHIPPING DAYS.
- 3. The live foal guarantee will apply to the following breeding season only. This guarantee applies only if Turnpike Equine or Kevin George are notified within 7 days of the death of the original foal. This notice must be accompanied by a statement from a licensed veterinarian. There will be an additional booking fee (rebreed fee) when semen is requested the following year. You may substitute the rebreed to a different mare. If this is a leased mare and the mare is returned and the owner of the mare fails to request semen the following year, then any and all fees shall be non refundable and this contract is thereby cancelled. Any failure to request semen during the designated season will result in forfeiture of booking fees. This will be at the sole discretion of Turnpike Equine.
- 4. A "Breeders Certificate" will be issued upon notification of the birth of the foal.
- 5. Turnpike Equine PLLC agrees to ship cooled transported semen as described above. If the Mare fails to settle for any reason, the Mare Owner will not hold Turnpike Equine PLLC liable in any respect whatsoever.
- 6. The parties acknowledge that this Agreement is made and shall be entirely performed within the State of Oklahoma and shall be constructed and enforced under the laws of the State of Oklahoma. Under Oklahoma Law, an Equine Professional is not liable for any injury or the death of a participant in Equine activities resulting from the inherent risks of Equine activities.
- 7. The Mare Owner agrees that Turnpike Equine has not made, and does not make, any representation or warranty as to the quality or conformation of the foal nor that the foal will be free of any infirmity, conformation defect, disease, or inherited trait. Turnpike Equine makes no implied guarantees for health or fitness for use in the future.
- 8. This Agreement shall be binding upon the parties hereto, upon execution hereof, and the

same may not be altered or amended, except by written mutual consent of the parties hereto.

9. This Agreement entitles the Mare Owner to one Breeders Certificate for one foal. If multiple embryos/foals are produced as a result of this breeding, additional breeding certificates will be provided after the Turnpike Equine PLLC has been provided with the additional contracts and stud fees associated with those additional foals.

- 10. Turnpike Equine PLLC only assumes responsibility to ship semen in viable condition and shall not be held liable for contamination of semen during and after shipment, loss of viability, or any costs arising from shipments being delayed, damaged or lost by the shipping company. Turnpike Equine PLLC does not guarantee the fertility of the stallion but agrees to process each ejaculate to optimize semen performance after shipment. Mare Owner will use best efforts to inseminate the Mare within 12-24 hours of receiving semen shipment. Mare Owner agrees to use all cooled semen provided by this Agreement for the Mare named herein.
- 11. Mare Owner agrees to provide Turnpike Equine PLLC with pregnancy status updates at 15 days post-insemination. Mare Owner also agrees to provide Turnpike Equine PLLC with a positive heartbeat confirmation within 35 days post-insemination.
- 12. Mare Owner agrees to the rates listed in the fee schedule above. Outstanding balances are subject to a 3% service charge.
- 13. Turnpike Equine PLLC does not carry mortality insurance on the breeding horses and therefore, Mare Owner must provide his/her/its own insurance if desired. Turnpike Equine PLLC shall not be liable for any damages to the Mare arising out of or from the breeding of the Mare. Turnpike Equine PLLC will also not be liable for any accident or injury that may occur to the Mare during the course of pregnancy that results in the loss of the pregnancy.
- 14. It is further understood that should the above named Stallion die or become unfit for service this contract shall become null and void and any breeding fee except the deposit will be returned by the Stallion Owner.
- 15. Semen used for ICSI could result in multiple embryos. Should this occur, additional stallion fees will be assessed at the current rate relative to the year the pregnancies are obtained.

- 2. Follow the steps below to order and pick up your cooled semen.
 - A. Shipping Days Beginning on February 3, 2025, and we will collect every Monday, Wednesday, and Friday until June 30, 2025.
 - B. A stallion contract and copy of the mare's registration papers must be on file.
 - C. All stallion and booking fees must be paid prior to or on the day of ordering transported semen.
 - D. A current credit card must be on file for shipping.
 - E. Your veterinarian/mare manager must call the day prior to collection day by 5:00 pm (CST) to place your mare on the shipment request list.
 - F. Your veterinarian/mare manager must call prior to 8:00am (CST) on the collection day to cancel your shipment. If you do not call by 8:00 am, your semen order will be shipped as scheduled and the mare owner will be charged for shipping.
 - G. ORDERS CALLED IN AFTER 5:00 PM THE DAY PRIOR TO COLLECTION ARE SUBJECT TO A \$100.00 LATE FEE SURCHARGE.
